### <u>State Library Resource Center (Liz Sundermann-Zinger)</u>

- SLRC Digital Presence Plan Update Now in the design phase, with August launch.
- Candice Zhu, Chief of Digital Transformation, is leaving at the end of the month.

### <u>Sailor Updates/Issues – (Candice Zhu and Mike Brown)</u>

- **Bandwidth upgrades** Rockville upgrade completed tomorrow. Fiber construction. Hagerstown completed, but issues with Verizon local loop.
- Secondary Point in Baltimore Have not started yet. Comcast missed two option years on the contract. ESRL is bringing up new data center and Sailor is running a circuit for them.
- VMware purchased by Broadcom, and they really cater to about the top 2K customers.
  Price increases 700-2K%. Starting an evaluation of what to move to. Probably Hyper-V (Microsoft)
- **Server Upgrades**: Completed to new version
- **Procurement of Learning Management System (LMS)**: Procurement completed. Third week of implementation. May offer training statewide through it. Can track CEUs.
- Partnership with University of Maryland Digital Navigators: The tech competency training is being developed by UM staff and Pratt library staff are piloting. There is a potential that it may be rolled out to the public and to library workers throughout the state. Participants take an assessment to find out what they need to learn, then enroll in the needed modules.

• The new ticketing system is currently only being used by Pratt IT and HR. At some point, however, may be able to expand to the state level.

- **Delivery Update** Things are going well from the study. No moving into a finalized contract for 4 years, with ability to expand and change.
